Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

All staff engaged in the sale of alcohol will be trained in respect of their legal and social responsibilities whilst doing so they will also be trained in the contents of the premises licence including any conditions contained therein. We will at all times have at least two employees at any one time while customers are on our premises so as to safeguard public safety and to make sure customers or children are not causing a nuisance. CCTV system will be used.

b) The prevention of crime and disorder

Alcohol shall only be sold to persons 18 years or older. No selling of alcohol to drunk or intoxicated customers. Staff will be well trained in asking customers to vacate the premises in an orderly and respectful manner when leaving our facilities.

c) Public safety

Internal and external lighting fixed to promote the public safety objective as well as trained staff adherence to environmental health requirements. Training and implementation of underage ID checks. Staff will be trained in respect of the fire risk assessment and the health and safety risk assessment. First Aid facilities shall be provided at the premises.

d) The prevention of public nuisance

Customers who wish to smoke at the premises will be permitted to do so in the designated areas. A notice will be displayed requesting persons who are using the outside areas to do so quietly respecting the needs of the local community.

e) The protection of children from harm

Challenge 25 to be operated at all times and anyone attempting to buy alcohol who appears to be under the age of 25 will have to provide photo ID in the form of an industry approved proof of age identity card, passport or photo driving licence to prove that they are 18 or over. Sign to be displayed at point of sale 'No proof of age – no sale'. A refusals/incident book, detailing all incidents where alcohol and other age related products are refused and any other relevant incidents, is to be kept and made available to authorised officers on request.
